4. SUMMARY OF SIGNIFICANT CHANGES.

A. ESTABLISHES OFFICER SI 1B TO IDENTIFY POSITIONS AND PERSONNEL WHO HAVE BEEN CERTIFIED AS A SEXUAL ASSAULT RESPONSE COORDINATOR (SARC) OR VICTIM ADVOCATE (VA) FOR THE SEXUAL HARASSMENT/ASSAULT RESPONSE & PREVENTION (SHARP) PROGRAM. ASSOCIATION WITH ANY OFFICER AREA OF CONCENTRATION (AOC) AUTHORIZED.

B. ESTABLISHES WARRANT OFFICER ASI 1B TO IDENTIFY POSITIONS AND PERSONNEL WHO HAVE BEEN CERTIFIED AS A SEXUAL ASSAULT RESPONSE COORDINATOR (SARC) OR VICTIM ADVOCATE (VA) FOR THE SEXUAL HARASSMENT/ASSAULT RESPONSE & PREVENTION (SHARP) PROGRAM. ASSOCIATION WITH ANY MILITARY OCCUPATIONAL SPECIALTY (MOS) AUTHORIZED.

C. ESTABLISHES ENLISTED ASI 1B TO IDENTIFY POSITIONS AND PERSONNEL WHO HAVE BEEN CERTIFIED AS A SEXUAL ASSAULT RESPONSE COORDINATOR (SARC) OR VICTIM ADVOCATE (VA) FOR THE SEXUAL HARASSMENT/ASSAULT RESPONSE & PREVENTION (SHARP) PROGRAM. ASSOCIATION WITH ANY MOS AUTHORIZED.

5. IMPLEMENTATION.

A. TRAINING STRATEGY. FOR AWARD OF SI/ASI 1B, OFFICERS/SOLDIERS MUST:

- (1) BE SELECTED BY THE COMMAND.
- (2) HAVE A FAVORABLE CRIMINAL BACKGROUND CHECK AND NATIONAL SEX OFFENDER REGISTRY CHECK.
- (3) HAVE STABILITY IN PERSONAL AFFAIRS; SOLDIER WILL NOT HAVE A RECENT HISTORY OF SEVERE DOMESTIC OR PERSONAL PROBLEMS (EXCLUDING DIVORCE), CHRONIC INDEBTEDNESS, EXCESSIVE USE OF ALCOHOL, OR ANY USE OF ILLEGAL DRUGS. INDIVIDUALS WITHDRAWN FOR CAUSE FROM ANY HUMAN RELIABILITY OR PERSONAL RELIABILITY PROGRAM DURING THE 2 YEARS PRECEDING THE NOMINATION WILL NEED A WAIVER FROM HQDA, G-1 SHARP.
- (4) COMPLETE THE CERTIFIED NATIONAL ORGANIZATION FOR VICTIMS ASSISTANCE (NOVA) 80-HOUR SHARP CERTIFICATION COURSE (SCHOOL CODE SHE).
- (5) POSSESS A CERTIFICATION ISSUED AND APPROVED BY THE DEPARTMENT OF DEFENSE SEXUAL ASSAULT ADVOCATE CERTIFICATION PROGRAM (D-SAACP) (APPLICATION FORM (DD FORM 2950)), AND THE D-SAACP NATIONAL ADVOCATE CREDENTIALING PROGRAM (NACP) COMMITTEE.
- (6) SEXUAL ASSAULT RESPONSE COORDINATOR (SARC/ SHARP): (A) MUST BE AN NCO (SFC OR HIGHER), OFFICER (MAJ/CW3 OR HIGHER) OR RECEIVE APPROVED REQUEST FOR EXCEPTION TO POLICY; (B) HAVE TWO LETTERS OF RECOMMENDATION: (1) THE SARC SUPERVISOR AND (2) THE SENIOR COMMANDING OFFICER.
- (7) VICTIM ADVOCATE (VA): (A) MUST BE AN NCO (SSG OR HIGHER), OFFICER (1LT/CW2 OR HIGHER) OR RECEIVE APPROVED REQUEST FOR EXCEPTION TO POLICY, (B) MUST HAVE TWO LETTERS OF RECOMMENDATION: (1) THE SARC AND (2) THE SUPERVISOR.
- (8) APPLICANTS WHO MEET THE ARMY REQUIREMENT AND HAVE BEEN CREDENTIALLED BY D-SAACP NACP COMMITTEE ARE QUALIFIED TO BE AWARDED THE SHARP SI/ASI 1B.
- (9) CURRENTLY, TRAINING IS CONDUCTED VIA MOBILE TRAINING TEAMS (MTT) AND ESTABLISHMENT OF SI/ASI 1B HAS NO IMPACT ON ARMY TRANSIENTS, TRAINEES, HOLDEES AND STUDENTS ACCOUNT REQUIREMENTS.
- (10) THERE IS NO CHANGE TO THE CURRENT TRAINING STRATEGY AS A RESULT OF THIS PROPOSAL, NOR IMPACT UPON THE TRAINING BASE AS IT PERTAINS TO ACCESSION MANAGEMENT.

B. ARMY RECRUITING INFORMATION SUPPORT SYSTEM (ARISS). THIS REVISION WILL NOT REQUIRE A CHANGE TO BE MADE TO ARISS.

C. POSITION RECODING. POSITION RECLASSIFICATION TO INCLUDE REVISION OF DUTY POSITION TITLES, GRADES AND IDENTIFIERS WILL BE ACCOMPLISHED DURING THE FY14 COMMAND PLAN TO ALL AUTHORIZED REQUIREMENT DOCUMENTS IN EFFECT ON OR AFTER 1 OCTOBER 2013 AS A DEPUTY CHIEF OF STAFF G-3, APPROVED EXCEPTION TO THE NORMAL DOCUMENTATION TIMELINES.
